## Terry's Machine Shop Informed Consent

I, \_\_\_\_\_ will be working in a machine shop and other facilities to fabricate, assemble, test, and operate a robot and related equipment designed by FIRST Robotics Team 2910 and therefore acknowledge the following:

- Participation is voluntary and at my own risk;
- Working with machinery such as a lathe, mill, or any tool used in the fabrication of a robot is an inherently dangerous activity and voluntarily assumes the risks of bodily injury, property damage and/or death, which may be incurred as a result of participating in such an activity;
- I affirm, to the best of my knowledge, that I am physically and mentally capable of operating the aforementioned equipment, and I am free from cardiovascular, respiratory or other diseases or ailments, which could impair my abilities while operating such machinery;
- I may be subjected to bodily injury from carelessness due to the activity, and/or related equipment handling, and/or from just being present at the location(s);
- I agree to abide by all the rules and instructions provided to me to fabricate a robot. I also agree to wear all necessary safety equipment when working with machinery;
- I am ultimately responsible for my own safety and at any time can refuse to work with any machinery or tools including other items used in the shop such as chemical compounds, paints, resin, fiberglass, etc;
- In the event that a need for emergency medical services arises, I authorize and consent to such service being provided and assume the cost thereof;
- At all times I shall heed posted warnings and refrain from acting in a manner which may cause or contribute to the injury of myself or others;

I, along with my parent or legal guardian, do waive, release, and discharge FIRST Robotics Team 2910 members, Sponsoring Facilities and their employees, Everett School District, The State of Washington, its governors, trustees, officers, employees, and agents from any and all claims, demands, actions, causes of actions, costs and expenses for and by reason of any personal injury, property damage, loss and expense, which heretofore have been or hereafter may be sustained or suffered by me in consequence of and as a result of a certain accident, casualty or event or my presence or activities in connection with fabricating a robot and related equipment.
